Entry Form and Supplementary Regulations

- DEFINITION The Nottingham Classic Tour is a Touring Assembly for road cars manufactured during the period 1st January 1900 and 31st December 1999, cars manufactured in Nottinghamshire and for other interesting road vehicles at the organiser's discretion
- ORGANISATION The event is organised by Carlton & District Motor Club Ltd under a Certificate of Exemption issued by Motorsports UK
- 3. All participants undertake to comply with these regulations by the fact of their entry.
- 4. **ROUTE** The route will start and finish at the designated venue and consist of tulip road book navigation to specified points on the tour. The approximate length will be 120 miles. Route instructions will be issued by the organisers at the start of the event.
- 5. **ELIGIBILITY** All vehicles must be correctly registered and currently licensed with a valid VOSA test certificate or equivalent. It is the responsibility of all participants to ensure the roadworthiness of their vehicle. Trade plates are forbidden. Valid insurance in accordance with the road traffic act is compulsory. Participants and drivers will be obliged to sign a declaration that they are covered by insurance. The maximum number of starters will be 60, each vehicle will be provided with an individually numbered rally plate, which must be positioned in a forward facing manner. No other numbers or trade advertising is permitted. Competition licences are not required.
- 6. INDEMNITY-All participants must sign an indemnity required under the terms of any policy held by the organisers of the event.
- 7. PETS-are permitted but not inside venues with exception of assistance dogs.
- 8. **ENTRIES**-Entries open on 1st January 2019

- 9. and close one week prior to the event. Entries are accepted on a first come first served basis. The selection of entries is at the absolute discretion of the organisers. All entries will be acknowledged and further instructions issued by newsletter or final instructions. Final instructions will be posted to participants no less than one week before the event. Single occupancy entries will not be accepted.
- 10. CANCELLATION-The organiser reserves the right to cancel or postpone the event or any part thereof should any circumstances arise which cause such action to be taken. In such circumstances the return of the entry fee in whole or part will be at the organiser's discretion.
- 11. **PENALTIES**-The Clerk of the Course has absolute discretion in the application and amendment of any penalty for any breach of these regulations and may implement decisions on any matter not provided for by these regulations.
- 12. CHANGE OF VEHICLE -Substitute vehicles will be placed in a starting position reflective of that car's age.
